Minutes of the Parish Council Meeting held on Tuesday 14 March 2017 held at 7.30pm in Almscliffe Hall.

1. **Apologies** from N.Anderson and H.Bosworth.
Members of the Council:- B.Wilyman, D.Needham, P.Galloway, P.Jagger. C.Trotter and S.Fawcett also attended.
2. **Minutes** of the last meeting held on 10 January 2017, having been circulated were taken as read as being a true record of that meeting, proposed by D.Needham and seconded by B.Wilyman.
Matters for the last meeting. B.Wilyman advised that he has placed an article about the service of M.Styrin during his time on the Parish Council.
Defibrillator training on public awareness took place and was attended by 15/20 residents. Due to the location of the unit a PIR light was required to light up the unit. A rota for regular weekly checks was to be raised at the Hall meeting.

- a. 17/00412/FUL, first floor extension at The Garth Brook Lane for Mr& Mrs Butler. No objections.
- b. 17/00100/FUL, alterations to porch fenestration and replacement roof at Thornton Rust Weeton Lane for Mr Wakelin. No objections *Approved*.
- c. 17/00109/FUL, first floor extension and alterations to existing extension at Merrybank, Merrybank Lane for Mr Locke. No objections. *Approved*.
- d. 16/05627/FUL, 2 storey extensions, first floor extension over garage, dormer windows, alterations to fenestration and access to public road for Mr Johnson. No objections but concern about visibility for new access.
- e. 17/00285/OUT, erection of agricultural dwelling at Cara Kelly Farm Gravelly Hill Lane for Mr & Mrs Denham. Concern about development on green belt, about the construction of the dwelling and viability of the size of the farm to support three agricultural workers.
- f. Concern about new gateway posts at Linden Lodge. The plans are approved. NYCC to be contacted about the visibility splay on the A658. C.Trotter to discuss with Area6 Boroughbridge.
- g. Enforcement case 17/00084/PR15 on erection of gate posts adjacent to A658 at 2 Wayside Terrace.
- h. HBC application for exchanging land at 44 Kingsway to enable building of apartments adjacent to garages. Concern that entrance to the site narrow and the use of Kingsway for railway parking.

Speed Watch. A training afternoon will take place on 15 March and 19 volunteers have agreed to take part in the training before the speed gun is made available.

Parish Plan. A meeting involving residents and the groups who use the Hall facilities is planned for spring or early summer.

Highway repairs and new 30mph signs. Following the repairs made to the highway on Strait Lane a wall has subsided just before Grosvenor Gardens.

C. Trotter agreed to speak to Area6 Boroughbridge regarding the following items:- Blockage under the railway bridge, due to the location of the drain. Blocked drains 18/20 Kingsway. 30mph sign opposite Cricket Club grounds. Pothole repairs.

Road sweep.

Kingsway verges being damaged by vehicles turning around. The Clerk to find out from HBC who cuts verges at the bottom of Kingsway. Are they NYCC verges?

Councillors requested details of grass cuts by S.Hesselden Ltd. These were sent during the budget process but the Clerk was to resend them again.

Crime figures for Huby, 7 instances 4 garage breakins and 3 houses. Residents to be aware and report to the Police.
