WEETON PARISH COUNCIL

Minutes of the Parish Council Meeting held on Tuesday 14 January 2020. At 7.30pm in Almscliffe Hall.

- Apologies from H.Boswoth.
 Members of the Council: B.Wilyman,K.Clark, J.Cheseldene, N. Anderson M.Styrin. C.Trotter and V.Oldman also attended.
- 2. Declarations, None.
- 3. Minutes of the last Meeting held on 19 November 2019, having been circulated were approved as being a true record, proposed by N.Anderson and seconded by J.Cheseldene. The Chairman duly signed the Minutes.
- 4. Ongoing issues not already resolved.

Drain under the Weeton Lane Railway Bridge. No further action. Councillors suggested that residents should report the flooding and silt occurring under the Railway Bridge to Area6 Boroughbrdige.

Report of health of the Ash Tree on the Weeton Village Green. P. Jagger is to contact One World for details of a arborist to carry out a survey of the top of the tree to report on Die Back. Following this survey the Council will need to appoint a tree surgeon to carry out work reported in the One World survey. Railway ticket machine. The persons who were charged the fine are to be reimbursed. Progress on the goods yard belonging to Network Rail being turned into extra parking is ongoing. C. Trotter suggested that a site meeting should be arranged with Network Rail, Northern and Councillors to discuss change of use to car parking and how this would be financed. K. Clark is to make further enquiries. Some new signage by Northern is to be erected at the station regarding tickets to Harrogate.

Parking at the corners of Strait Lane. A plan of the suggested double yellow lines has been sent by NYCC to Councillors. Councillors agreed that on safety grounds these lines should be installed, however it was considered that parking would then take place higher up Strait Lane which may cause further obstructions for HGV's requiring access for delivery or collections. Again a meeting was to be considered with NYCC.

- B. Wilyman reported that the bluebells have been planted on Huby Banks and at the top of Strait Lane.

NYCC budgets are being discussed to save £17million. Funding has been promised from the government towards pot holing work.

HBC the building at Crescent Gardens has been sold for office accommodation and a possible restaurant with questions being raised about the parking in front of the building. Funds raised from the sale will be put towards the newly located HBC Offices.
